Recently, I was privileged to partner with several students in presenting a **"state-of-the-school"** video series. The intention was to provide our community with a narrative summary of where Gross Catholic stands on several fronts – cultural, operational, financial, strategic. It complements this 2020 - 21 annual report in two ways: 1) it fleshes out the data points shared in the following pages; and 2) offers perspective on the distance we've come in just a short time thanks to the trust and philanthropy of parents, donors, and friends of the school. One thing is abundantly clear: We are positioned – and ready – for growth in all areas.

And we *are* growing. The latest numbers indicate that this fall we will have the largest incoming freshman class in the last three years. We have added several new staff positions that will provide greater facility and service to students and families. New teachers and coaches are being hired as I write this letter. On the curriculum front, starting next fall, we will have three dual-credit academies: Health Science Career, STREAM Academy with a math and computer science track, and Health and Athletic Training. Advancement efforts have made great strides this year, breaking records in event participation and fundraising. Capital upgrades – including a state-of-the-art Innovation Center, installation of new lights on the baseball field, and plans to completely renovate all classrooms and labs – demonstrate where we can and must provide students with needed resources.

None of these would be possible without the generosity of our benefactors. To you I extend my deepest gratitude. You have opened students to one of life's greatest treasures: the gift of a Gross Catholic education. You've ensured that we remain one of Nebraska's premier Catholic high schools. The quality of the integral education, the Catholic and Marianist values, the spirit of family and lifelong friendships – you've shown these qualities to be worth investing in, for the return is everlasting.

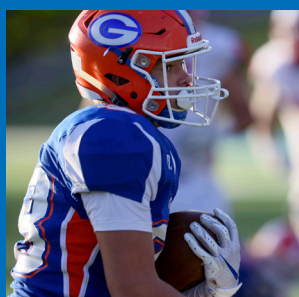
Gross Catholic High School is a co-ed, college preparatory school that strengthens our youth to meet the challenges of an ever-changing world...to be leaders.

- Despite COVID restrictions, all-school Masses, Reconciliation services, and retreats were uninterrupted.

Purposefully Compassionate.

We value leadership within our community that is dedicated to supporting each other. By praying with one another, we enrich our faith and strengthen our ability to meet the challenges of our ever-changing world. We demonstrate this value by being a welcoming, inclusive and supportive community. - Students and staff provided 8 families impacted by COVID with Christmas presents and grocery gift cards.

- We awarded 1.8 million in scholarships and grants to over 80% of students in the 2020 - 2021 school year.

- Brooklyn Kottich, Jenna Skradski, Jordan Skradski and Ellie Zoucha were named RCC All-Conference Softball Players.

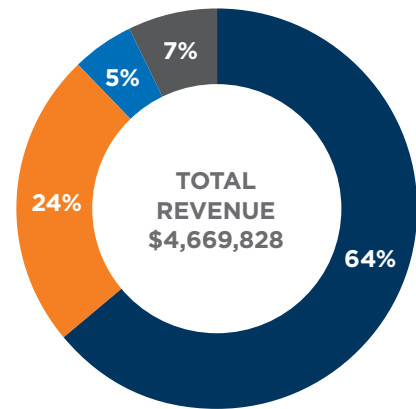


FINANCIAL STATEMENT

The cost to educate our students in 2020 - 2021 was \$12,700 per student, and tuition was set at \$11,140. Every student benefitted from a \$1,560 tuition grant and 80 percent of our students received additional assistance through our Individualized Tuition Plans, academic scholarships and tuition grants totaling \$1.8 million. The average award was \$4,923 per student.

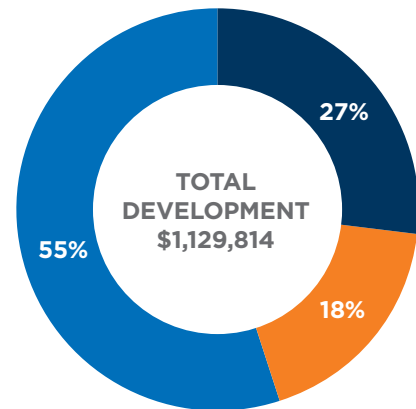

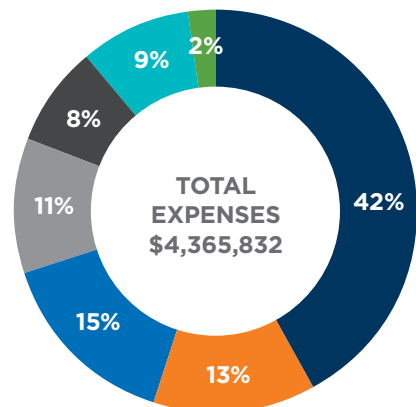
